The bank credit segment accounted for the industry group's largest proportion in 2022, with total assets of \$139 billion, equivalent to 72% of the industry group's overall value.

According to the OECD, the long-term interest rates of Colombian banks had increased significantly during the historic period, from 6.8% per annum in December 2017 to 12.3% per annum in January 2023.
