Summary

Metals & Mining in Colombia industry profile provides top-line qualitative and quantitative summary information including: market size (value 2017-22, and forecast to 2027). Key Highlights

The metals & mining market includes aluminum, steel, iron ore, coal, base metals, and precious metals. Market volume includes production volume and market value is calculated by multiplying market volume with production price.

The Colombian metals & mining industry had total revenues of \$21.7 billion in 2022, representing a compound annual growth rate (CAGR) of 17.2% between 2017 and 2022.

The production volumes declined with a negative CAGR of 7% between 2017 and 2022, reaching a total of 64,405.9 thousand tonnes in 2022.

The expansion of new projects and increased production efficiencies are driving growth in Colombia's metals and mining industry. Due to high worldwide prices and positive demand prospects, the gold, copper, and nickel sectors are anticipated to be more promising.
