The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The confectionery industry within the NAFTA countries had a total market value of \$57,431.6 million in 2023. The US was the fastest growing country, with a CAGR of 6.1% over the 2019-23 period.

Within the confectionery industry, the US is the leading country among the NAFTA bloc, with market revenues of \$47,854.2 million in 2023. This was followed by Mexico and Canada, with a value of \$5,535.8 and \$4,041.6 million, respectively.

The US is expected to lead the confectionery industry in the NAFTA bloc, with a value of \$56,078.4 million in 2028, followed by Mexico and Canada with expected values of \$7,315.1 and \$4,851.9 million, respectively.
