It owns 25 licenses for zinc and lead exploration and 15 licenses for gold exploration. The company's licensed properties include Monaster block, Oldcastle Block, Rapia Licence, Wicklow-Wexford block, inishowen block and Donegal licences. The company directly owns 20 licenses which include 10 each for zinc and gold exploration; ten licenses through Teck joint venture for zinc exploration; and other five with Hendricks joint venture for gold exploration. The company's Inishowen block consists of 5 licences covering 187 Sqmt. Connemara is headquartered in Dublin, Ireland.
