The aggregates segment was the market's most lucrative in 2020, with total revenues of \$1.7bn, equivalent to 55.5% of the market's overall value.

The value of the Scandinavian construction materials market declined by 4% in 2020 as a result of the COVID-19 pandemic which reduced construction activity.
