#### **SUMMARY**

The NAFTA Construction Materials industry profile provides top-line qualitative and quantitative summary information including: market size (value 2016-20, and forecast to 2025). #### **KEY HIGHLIGHTS**

The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The construction materials industry within the NAFTA countries had a total market value of \$66,188.4 million in 2020. The US was the fastest growing country, with a CAGR of 3.3% over the 2016-20 period.

Within the construction materials industry, the US is the leading country among the NAFTA bloc, with market revenues of \$51,486.4 million in 2020. This was followed by Mexico and Canada, with a value of \$9,537.8 and \$5,164.2 million, respectively.

The US is expected to lead the construction materials industry in the NAFTA bloc, with a value of \$66,101.3 million in 2025, followed by Mexico and Canada



with expected values of \$13,143.2 and \$6,732.6 million, respectively.
