KEY HIGHLIGHTS

The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The consumer electronics industry within the NAFTA countries had a total market value of \$396,043.2 million in 2020.The Mexico was the fastest growing country, with a CAGR of 4.1% over the 2016-20 period.

Within the consumer electronics industry, the US is the leading country among the NAFTA bloc, with market revenues of \$341,745.9 million in 2020. This was followed by Mexico and Canada, with a value of \$27,395.8 and \$26,901.5 million, respectively.

The US is expected to lead the consumer electronics industry in the NAFTA bloc, with a value of \$375,472.2 million in 2025, followed by Mexico and Canada



with expected values of \$36,243.4 and \$30,109.8 million, respectively.
