Key Highlights

The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The containers & packaging industry within the NAFTA countries had a total market value of \$181.5 billion in 2023. The Canada was the fastest growing country, with a CAGR of 3.3% over the 2019-23 period.

Within the containers & packaging industry, the US is the leading country among the NAFTA bloc, with market revenues of \$135.1 billion in 2023. This was followed by Mexico and Canada, with a value of \$27.6 and \$18.8 billion, respectively.

The US is expected to lead the containers & packaging industry in the NAFTA bloc, with a value of \$138.5 billion in 2028, followed by Mexico and Canada with expected values of \$30.9 and \$19.8 billion, respectively.
