### SUMMARY

The German control systems market had total revenues of \$2.5bn in 2020, representing a compound annual growth rate (CAGR) of -1.0% between 2016 and 2020.

The PLC segment was the market's most lucrative in 2020, with total revenues of \$1.7bn, equivalent to 67.7% of the market's overall value.

The introduction of government policies to boost industrial production, such as

the Made in Germany: Industrial Strategy 2030, should benefit the market going forwards.
