The Czech non-life insurance market had total gross written premiums of \$5.9 billion in 2022, representing a compound annual growth rate (CAGR) of 9.6% between 2017 and 2022.

The motor segment accounted for the market's largest proportion in 2022, with total gross written premiums of \$2.7 billion, equivalent to 46.7% of the market's overall value.

Non-life insurance coverage in the Czech population is relatively low. According to in-house research, in 2022, the Czech Republic's non-life insurance penetration (ratio of premiums to GDP) stood at 2%.
