The Danish aerospace & defense market had total revenues of \$0.7 billion in 2022, representing a negative compound annual growth rate (CAGR) of 25.3% between 2017 and 2022.

The systems & ordnance segment accounted for market's the largest proportion in 2022, with total revenues of \$0.4 billion, equivalent to 53.2% of the market's overall value.

. The increase in Danish defense expenditure is primarily driven by the government's response to the conflict in Ukraine and continuing pressure to



meet NATO's 2.0% of GDP spending target.
