The bank credit segment accounted for the industry group's largest proportion in 2022, with total assets of \$610.3 million, equivalent to 44.4% of the industry group's overall value.

According to the OECD, the long-term interest rates of Danish banks had increased significantly during the historic period, from 0.4% per annum in December 2017 to 2.3% per annum in December 2022.
