SUMMARY

The Danish Construction industry had total revenues of \$57.6bn in 2021, representing a compound annual growth rate (CAGR) of 8% between 2016 and 2021.

The Non-Residential Construction segment was the industry's most lucrative in 2021, with total revenues of \$31.6bn, equivalent to 54.7% of the industry's overall value.

Containment measures and COVID-19 prevention efforts added significantly to the costs incurred by transporting companies which reduced the incentive to build throughout the year.
