The non-residential construction segment accounted for the industry's largest proportion in 2022, with total revenues of \$29,786.4 million, equivalent to 54.6% of the industry's overall value.

The Danish construction industry has expanded in the past few years, owing to several factors such as a growing economy, an increase in urbanization, an increase in consumer spending, and government initiatives.
