SUMMARY

The outpatient care segment was the sector's most lucrative in 2021, with total revenues of \$10.0 billion, equivalent to 30.1% of the sector's overall value.

The value of the Danish healthcare providers sector grew by 3% in 2021, a weaker rate compared to 2020, as a result of the health expenditure in response



to the COVID-19 pandemic.
