Summary

The Danish life insurance market had total gross written premiums of \$32.6 billion in 2022, representing a compound annual growth rate (CAGR) of 7.1% between 2017 and 2022.

The life insurance segment accounted for the market's largest proportion in 2022, with total gross written premiums of \$26.6 billion, equivalent to 81.4% of the market's overall value.

Life insurance coverage in the Danish population is relatively high. According to in-house research, in 2022, life insurance penetration (ratio of premiums to GDP) in Denmark was 9%.
