The company distributes its products and service through direct market channel, independent agents and insurance and reinsurance brokers. The company has offices in London, New York, Zurich, Singapore and Hamilton. Endurance is headquartered in Hamilton, Bermuda.

The company reported gross premiums written of US\$3,320.9 million during the fiscal year ended December 2015 (FY2015), representing an increase of 14.7% over FY2014. Its net premium written was US\$1,950.5 million in FY2015, representing an increase of 0.8% over FY2014.
