SUMMARY

KEY HIGHLIGHTS

The air freight sector is defined as consisting of revenues generated from freight transportation by air.

The European air freight sector had total revenues of \$23.2 billion in 2022, representing a negative compound annual growth rate (CAGR) of 3% between 2017 and 2022.

Sector consumption volumes declined with a negative CAGR of 2.6% between 2017 and 2022, reaching a total of 38.2 billion FTK in 2022.

The European air freight sector has declined recently owing to several factors such as increasing interest rates and rising inflation. High-interest rates reduce access to credit for the companies involved, thereby reducing the volume of investment which negatively impacts air freight. For instance, according to the OECD, the long-term interest rates in Norway grew from 1.3% in December



2017 to 3.5% in December 2022.
