The commodity chemicals segment accounted for the largest proportion of the market in 2021, with total revenues of \$388.5 billion, equivalent to 39.2% of the market's overall value.

In 2021, the European market accounted for 20.9% of the global market's total value, making it the second largest region worldwide after Asia-Pacific. The German market is the largest in the region, accounting for 20.9% of its total

value in 2021, therefore its performance is reflected in the region's as a whole.
