Exelis Inc. (Exelis) provides aerospace, defense and information solutions. The company offers C4ISR electronics and systems including intelligence, surveillance and reconnaissance systems, integrated electronic warfare systems and electronic attack and release systems. It also offers radar and reconnaissance systems, communications solutions, night vision, positioning, navigation and timing, aerostructures, specialty applications and undersea systems. Exelis offers information and technical services such as advanced information solutions, civil and aerospace systems and command, control and communications systems. Its major customers include the US Department of Defense (DoD) and its prime contractors, the National Aeronautics and Space Administration (NASA), US Government intelligence agencies, the Federal Aviation Administration (FAA), allied foreign governments and domestic and foreign commercial customers. In February 2015, Exelis entered into a merger agreement with Harris Corporation and after the merger, Exelis' business operations will be integrated into Harris Corp, this transaction is expected to close in June 2015. Exelis is headquartered in McLean, Virginia, the US.

To strengthen aviation solutions portfolio and international market position, the company acquired Barco Orthogon (Orthogon), a provider of applications for air traffic flow management and air navigation service in August 2014.
