Finland Non-Life Insurance Market @Summary, Competitive Analysis and Forecast to 2027

#### **SUMMARY**

Non-Life Insurance in Finland industry profile provides top-line qualitative and quantitative summary information including: market size (value 2017-22, and forecast to 2027). The profile also contains descriptions of the leading players including key financial metrics and analysis of competitive pressures within the market.

#### **KEY HIGHLIGHTS**

The non-life insurance market consists of the general insurance market segmented into motor, property, liability and other insurance. The other segment is made up of non-life insurance products including health, travel, and accident cover among others. The value of the non-life insurance market is shown in terms of gross premium incomes. Gross premium income is defined as the insurer's premium income for the year from its policies, calculated without reduction for reinsurance premiums paid or payable by the insurer.

The Finnish non-life insurance market had total gross written premiums of \$6 billion in 2022, representing a compound annual growth rate (CAGR) of 3.6% between 2017 and 2022.

The Motor segment accounted for market's the largest proportion in 2022, with total gross written premiums of \$2.3 billion, equivalent to 38.1% of the market's



overall value.

In 2022, inflation will increase insurance prices for customers in Finland, and non-life insurance companies will face higher claim costs as a result. The Property segment contributed gross written premiums of \$1.3 billion in 2022, equating to 22.5% of the market's aggregate value.
