SUMMARY

The NAFTA Fish & Seafood industry profile provides top-line qualitative and quantitative summary information including: market share, market size (value and volume 2015-19, and forecast to 2024). KEY HIGHLIGHTS

The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The fish & seafood industry within the NAFTA countries had a total market value of \$22,301.5 million in 2019. The Mexico was the fastest growing country, with a CAGR of 4.1% over the 2015-19 period.

Within the fish & seafood industry, the US is the leading country among the NAFTA bloc, with market revenues of \$12,678.2 million in 2019. This was followed by Mexico and Canada, with a value of \$7,397.9 and \$2,225.3 million, respectively.

The US is expected to lead the fish & seafood industry in the NAFTA bloc, with a value of \$14,266.1 million in 2024, followed by Mexico and Canada with expected values of \$8,345.0 and \$2,474.6 million, respectively.
