SUMMARY

Food and Grocery Retail in Singapore industry profile provides top-line qualitative and quantitative summary information including: market size (value 2014-18, and forecast to 2023). The food and grocery retail market includes the retail sales of all food products, both packaged and unpackaged, as well as beverages (including retail sales of all alcoholic and non-alcoholic beverages), tobacco, and household products. All on-trade sales of food and beverage are excluded. All currency conversions are calculated at constant average 2018 exchange rates.

The Singaporean food and grocery retail market had total revenues of \$11.4bn in 2018, representing a compound annual growth rate (CAGR) of 2.5% between 2014 and 2018.

The Food segment was the market's most lucrative in 2018, with total revenues of \$7.1bn, equivalent to 62.8% of the market's overall value.

In the most recent World Bank Human Capital Index, Singapore ranks the best country in the world in human capital development.
