SUMMARY

KEY HIGHLIGHTS

The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The food & grocery retail industry within the NAFTA countries had a total market value of \$1,795,882.2 million in 2020. The Mexico was the fastest growing country, with a CAGR of 7.9% over the 2016-20 period.

Within the food & grocery retail industry, the US is the leading country among the NAFTA bloc, with market revenues of \$1,446,851.2 million in 2020. This was followed by Mexico and Canada, with a value of \$205,752.7 and \$143,278.2 million, respectively.

The US is expected to lead the food & grocery retail industry in the NAFTA bloc, with a value of \$1,668,803.2 million in 2025, followed by Mexico and Canada



with expected values of \$276,477.2 and \$158,356.1 million, respectively.
