Within the footwear industry, China is the leading country among the BRIC nations with market revenues of \$65,015.3 million in 2017. This was followed by Russia, Brazil and India with a value of \$11,426.0, \$7,967.6, and \$5,959.8 million, respectively.



China is expected to lead the footwear industry in the BRIC nations with a value of \$1,06,033.9 million in 2022, followed by Russia, India, Brazil with expected values of \$14,086.0, \$10,211.4 and \$9,905.2 million, respectively.
