SUMMARY

Footwear in the United Kingdom industry profile provides top-line qualitative and quantitative summary information including: market size (value 2014-18, and forecast to 2023). The profile also contains descriptions of the leading players including key financial metrics and analysis of competitive pressures within the market.

KEY HIGHLIGHTS

The footwear market consists of the total revenues generated through the sale of all types of men's, women's and children's shoes. It includes all footwear categories for men, women, boys and girls, but excludes sports-specific footwear.

The UK footwear market is expected to generate total revenues of \$11.1bn in 2018, representing a compound annual growth rate (CAGR) of 1.7% between 2014 and 2018.

The women's footwear segment was the market's most lucrative in 2018, with total revenues of \$5.5bn, equivalent to 49.1% of the market's overall value.

The growing trend toward shopping online has negatively impacted a number for footwear retailers in recent years. Clarks, a leading player in the UK market, reported a loss after tax of ?31.3m (\$40.3m) for the year to January 31, 2018, down from a ?26.5m (\$34.2m) profit after tax the previous year.
