These countries contributed \$86,721.0 million to the global footwear industry in 2017, with a compound annual growth rate (CAGR) of 9.5% between 2007 and 2011. The top 5 emerging countries are expected to reach a value of \$1,36,995.6 million in 2022, with a CAGR of 9.6% over the 2017-22 period.

Within the footwear industry, China is the leading country among the top 5 emerging nations, with market revenues of \$65,015.3 million in 2017. This was followed by Brazil and Mexico with a value of \$7,967.6 and \$6,136.3 million, respectively.



China is expected to lead the footwear industry in the top five emerging nations, with a value of \$1,06,033.9 million in 2022, followed by India and Brazil with expected values of \$10,211.4 and \$9,905.2 million, respectively.
