Key Highlights

The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The fragrances industry within the NAFTA countries had a total market value of \$15,448.0 million in 2023. The US was the fastest growing country, with a CAGR of 7.2% over the 2019-23 period.

Within the fragrances industry, the US is the leading country among the NAFTA bloc, with market revenues of \$12,396.4 million in 2023. This was followed by Mexico and Canada, with a value of \$1,799.8 and \$1,251.7 million, respectively.

The US is expected to lead the fragrances industry in the NAFTA bloc, with a value of \$15,989.1 million in 2028, followed by Mexico and Canada with expected values of \$2,174.6 and \$1,482.9 million, respectively.
