SUMMARY

The mortgage credit segment accounted for the largest share of the market's balances outstanding in 2021, with total balances outstanding of \$1,585.9 billion, equivalent to 82.3% of the market's overall value.

Market growth has been driven by consistently low interest rates in wider Europe. This lowered the cost of borrowing, subsequently leading to the increased consumption of credit in both the consumer and mortgage markets.
