The G8 countries contributed \$6,197.1 billion in 2021 to the global healthcare providers industry, with a compound annual growth rate (CAGR) of 4.4% between 2017 and 2021. The G8 countries are expected to reach a value of \$7,838.5 billion in 2026, with a CAGR of 4.8% over the 2021-26 period.

Among the G8 nations, the US is the leading country in the healthcare providers industry, with market revenues of \$4,016.6 billion in 2021. This was followed by Germany and Japan, with a value of \$516.2 and \$455.0 billion, respectively.

The US is expected to lead the healthcare providers industry in the G8 nations with a value of \$5,288.5 billion in 2016, followed by Germany and Japan with expected values of \$617.3 and \$494.8 billion, respectively.
