Summary

The G8 Pharmaceuticals industry profile provides top-line qualitative and quantitative summary information including: market share, market size (value 2018-22, and forecast to 2027). Key Highlights

The G8 countries contributed \$774.7 billion in 2022 to the global pharmaceuticals industry, with a compound annual growth rate (CAGR) of 2.3% between 2018 and 2022. The G8 countries are expected to reach a value of \$897.4 billion in 2027, with a CAGR of 3% over the 2022-27 period.

Among the G8 nations, the US is the leading country in the pharmaceuticals industry, with market revenues of \$408.0 billion in 2022. This was followed by Japan and Germany, with a value of \$92.3 and \$83.2 billion, respectively.

The US is expected to lead the pharmaceuticals industry in the G8 nations with a value of \$463.0 billion in 2016, followed by Germany and Japan with expected values of \$107.9 and \$106.5 billion, respectively.
