Among the G8 nations, the US is the leading country in the residential construction industry, with market revenues of \$1,068,296.1 million in 2022. This was followed by Germany and the UK, with a value of \$245,992.9 and \$209,670.8 million, respectively.

The US is expected to lead the residential construction industry in the G8 nations with a value of \$1,171,929.8 million in 2016, followed by Germany and the UK with expected values of \$298,544.3 and \$276,786.4 million, respectively.
