Its offerings include commercial bonds, after the event (ATE) insurance, ATE financial litigation insurance, commercial combined insurance, property liability insurance, tenant deposit guarantee schemes, property construction liability insurance, third party liability insurance, commercial motor fleet insurance and contractors' all risks insurance. It markets and distributes its products through a network of selected brokers in European countries. The company has operations in the UK, Iceland, Ireland, France, Spain, Norway, Germany, the Netherlands, Denmark, Sweden and Italy. GHI is headquartered in George Town, the Cayman Islands.

The company reported gross written premium of GBP80 million during the fiscal year ended December 2014 (FY2014), representing an increase of 35.7% over FY2013. Its net earned premium was GBP51.4 million in FY2014, an increase of 22.3% over FY2013.
