SUMMARY

Games Software in Europe industry profile provides top-line qualitative and quantitative summary information including: market share, market size (value and volume 2016-20, and forecast to 2025). The market is valued at retail selling price (RSP) with any currency conversions calculated using constant 2020 annual average exchange rates.

The European games software market is expected to generate total revenues of \$13.3bn in 2020, representing a compound annual growth rate (CAGR) of 5.6% between 2016 and 2020.

As a digitally and technology-based market, the games software market has avoided many of the negative implications of self-isolation measures due to the global pandemic.

Smartphones are driving game software market growth as mobile gaming becomes increasingly popular.
