The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The games software retail industry within the NAFTA countries had a total market value of \$23,825.2 million in 2023. The Mexico was the fastest growing country, with a CAGR of 16.5% over the 2019-23 period.

Within the games software retail industry, the US is the leading country among the NAFTA bloc, with market revenues of \$20,897.8 million in 2023. This was followed by Mexico and Canada, with a value of \$1,467.6 and \$1,459.8 million, respectively.

The US is expected to lead the games software retail industry in the NAFTA bloc, with a value of \$22,513.3 million in 2028, followed by Mexico and Canada with expected values of \$1,824.6 and \$1,658.4 million, respectively.
