The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The gas utilities industry within the NAFTA countries had a total market value of \$391,331.3 million in 2022. The Canada was the fastest growing country, with a CAGR of 14.9% over the 2018-22 period.

Within the gas utilities industry, the US is the leading country among the NAFTA bloc, with market revenues of \$363,617.0 million in 2022. This was followed by Mexico and Canada, with a value of \$19,140.3 and \$8,574.1 million, respectively.

The US is expected to lead the gas utilities industry in the NAFTA bloc, with a value of \$454,254.9 million in 2027, followed by Mexico and Canada with expected values of \$24,450.7 and \$10,270.2 million, respectively.
