SUMMARY

Generics in Germany industry profile provides top-line qualitative and quantitative summary information including: market share, market size (value and volume 2016-20, and forecast to 2025). The profile also contains descriptions of the leading players including key financial metrics and analysis of competitive pressures within the market.

KEY HIGHLIGHTS

For the purposes of this profile, a generic drug is defined as a copy of an ethical (prescription) drug formerly protected by patents that have now expired. Both unbranded generics and all branded generics are included. However, off-patent drugs that continue to be offered by the original manufacturer under the original name, and which form part of the 'generic-eligible' market, are not included.

The German generics market had total revenues of \$25.2bn in 2020, representing a compound annual growth rate (CAGR) of 9.6% between 2016 and 2020.

Market consumption volume increased with a CAGR of 0.8% between 2016 and 2020, to reach a total of 90.8% in 2020.

In terms of generic medicines, Germany is a mature market; generics have been in use since 1974 and the market is the largest in Europe, accounting for 32.3%



of its total value in 2020.
