Summary

Generics in China industry profile provides top-line qualitative and quantitative summary information including: market share, market size (value and volume 2018-23, and forecast to 2028). Key Highlights

A generic drug is defined as a copy of an ethical (prescription) drug formerly protected by patents that have now expired. Both unbranded generics and branded generics are included in our market scope. However, off-patent drugs that continue to be offered by the original manufacturer under the original name, and which form part of the 'generic-eligible' market, are not included. Market value is evaluated at ex-factory prices. Market volume refers to the proportion of the total ethical pharmaceutical market in a country or region that is made up of generic drugs. Thus, it is a measure of the market share held by generics, rather than a direct measure of the total market volume. Regional volumes are calculated as averages of countries that comprise the region where volume data exists.

The Chinese generics market recorded revenues of \$121.0 billion in 2023, representing a compound annual growth rate (CAGR) of 12.7% between 2018 and 2023.

Market consumption volume increased with a CAGR of 0.5% between 2018 and



2023, to reach a total of 80.0% of total pharma volume in 2023.

According to GlobalData, in 2023, the Chinese generics market grew by 7.4% annually due to the country's mounting aging population. According to the World Bank, in 2023, the percentage of the population aged 65 years and above out of the total population in China reached 14.3% as compared to 13.7% in 2022.
