Industry consumption volumes declined with a CAGR of -18.2% between 2016 and 2021, to reach a total of 73.6 million seats sold in 2021.

The German airlines industry is the largest in Europe, accounting for 11.8% of the regional industry, followed by Spain, which accounts for 8.8% in 2021.
