SUMMARY

The physical segment of the books market includes atlases, dictionaries, encyclopedias, text books, guidebooks, musical scores, maps, fiction and non-fiction. The digital segment of the books market consists of electronic books which can be read on computers or other electronic devices such as tablets. Other segment includes magazines, download audio, physical audio and other not included in the above segments.

The German books market had total revenues of \$11.4bn in 2021, representing a compound annual growth rate (CAGR) of 0.7% between 2016 and 2021.

The Physical segment was the market's most lucrative in 2021, with total revenues of \$7.7bn, equivalent to 67.8% of the market's overall value.

German bookstores including the small ones have benefited from growing online



sales. Gradual relaxation in coronavirus control measures have renewed the customer footfall in bookstores leading to a positive impact on market revenue for 2021.
