The total value of the market represents the demand for the service coming from a particular country.

The German BPO services market had total revenues of \$10.4 billion in 2022, representing a compound annual growth rate (CAGR) of 6.1% between 2017 and 2022.

The vertical-specific BPO segment accounted for the market's largest proportion in 2022, with total revenues of \$2.8 billion, equivalent to 26.7% of the market's overall value.

With the concentration of a culturally diverse and large labor force, Germany is home to a highly qualified workforce with international experience. The strong tie-ups of Germany with central and eastern European countries create significant growth opportunities for the German BPO market.
