The residential construction segment accounted for the industry's largest proportion in 2022, with total revenues of \$246.0 billion, equivalent to 51.0% of the industry's overall value.

In 2022, the industry growth deaccelerated, owing to economic uncertainty, high energy price, high construction material costs, and rising inflation.
