The German control systems market had total revenues of \$3.0bn in 2021, representing a compound annual growth rate (CAGR) of 2% between 2016 and 2021.

The PLC segment was the market's most valuable in 2021, with total revenues of \$2.0bn, equivalent to 67.7% of the market's overall value.

Germany is the largest control system market in Europe accounting for 13.5% of



global market revenues.
