SUMMARY

Real Estate in Germany industry profile provides top-line qualitative and quantitative summary information including: market size (value 2017-21, and forecast to 2026). The real estate industry looks at renting and leasing residential properties. The industry is valued using the total revenues generated by landlords via the leasing and renting of private and council properties. Values are calculated using the average annual rent multiplied by the number of rented properties.

The German real estate industry had total revenues of \$271.8bn in 2021, representing a compound annual growth rate (CAGR) of 1.6% between 2016 and 2021.

Industry consumption volume increased with a CAGR of 0.1% between 2016 and 2021, to reach a total of 20.1 thousand units in 2021.

The value of the German real estate industry declined by 3.2% in 2021.
