SUMMARY

Software in Germany industry profile provides top-line qualitative and quantitative summary information including: market size (value 2017-21, and forecast to 2026). The profile also contains descriptions of the leading players including key financial metrics and analysis of competitive pressures within the market.

KEY HIGHLIGHTS

The software market is defined as revenues generated from both: sales of, and subscriptions to, various software packages and offerings. The market includes both signed deals that remain under contract, and the annual revenues associated with new contracts signed, within a particular calendar year. This excludes sales opportunities for third-party services providers.

The German software market had total revenues of \$36.2 billion in 2021, representing a compound annual growth rate (CAGR) of 5.9% between 2016 and 2021.

The business process applications segment was the market's most valuable in 2021, with total revenues of \$12.6 billion, equivalent to 34.9% of the market's overall value.

The COVID-19 crisis highlighted several examples of processes that can be



digitized and virtualized, which increased demand for software products.
