Summary

Waste Management in Germany industry profile provides top-line qualitative and quantitative summary information including: market size (value 2017-22, and forecast to 2027). Key Highlights

The market is segmented into MSW, medical and biomedical waste, electronic waste (e-waste), and industrial waste. The market scope excludes hazardous wastes such as explosives, flammable liquids/solids or substances, oxidizing substances, etc.

The German Waste Management industry had total revenues of \$49.5 billion in 2022, representing a compound annual growth rate (CAGR) of 2.5% between 2017 and 2022.

Industry consumption volume increased with a CAGR of 1.8% between 2017 and 2022, to reach a total of 367.4 thousand tonnes in 2022.

Germany accounted for a share of 15.1% of the European waste management industry in 2022.
