SUMMARY

The air freight sector is defined as consisting of revenues generated from freight transportation by air.

The global air freight sector had total revenues of \$117.3 billion in 2021, representing a compound annual growth rate (CAGR) of 2.4% between 2016 and 2021.

Sector production volume increased with a CAGR of 0.6% between 2016 and 2021, to reach a total of 189.3 billion freight ton-kilometers (FTK) in 2021.

The sector recorded steep decline in 2020 of 21.5% largely due to the COVID-19 pandemic. The leading players in the region were forced to follow government restrictions in order to curtail the spread of the virus.
