representing a compound annual growth rate (CAGR) of 4.7% between 2012 and 2016.

The bank credit segment was the industry group's most lucrative in 2016, with total assets of \$65,280.4bn, equivalent to 48.7% of the industry group's overall value.

Europe is riddled with political uncertainty at present. The terms of the UK's exit from the EU remain very much uncertain, while France and Germany are both due to hold parliamentary elections in 2017, the outcomes of which seem to be very uncertain. This creates questions over the industry in those countries and this is contributing to the fact that growth is only low.

Banks tend to form oligopolies in particular countries, with some truly multinational. Banks can also be bigger in either retail or investment banking.
