The medical/healthcare segment generated the most revenue in 2021, with total revenues of \$422.1 billion, equivalent to 56.8% of the market's overall value.

The US market is by far the largest globally, accounting for 38.7% of its total value in 2021. Comparatively, the entire Asia-Pacific and European regions accounted for 33.6% and 21.3% of the global market's value respectively.
