The total value of the market represents the demand for the service coming from a particular country.

The global BPO services market is expected to generate total revenues of \$266.2bn in 2020, representing a compound annual growth rate (CAGR) of 2% between 2016 and 2020.

The HR outsourcing segment is expected to be the market's most lucrative in 2020, with total revenues of \$81.5bn, equivalent to 30.6% of the market's overall value.

In developing markets, the growth of outsourcing activities has been driven by



the rapid growth of the emerging economies of these regions.
